

PRACTICE FACILITY RULES

ALL MEMBERS ARE REQUIRED TO READ AND FULLY UNDERSTAND THE RULES AND EXPECTATIONS OF THE PRACTICE FACILITY, THE FACILITY IS WITHIN THE NORTH YORKSHIRE MOORS NATIONAL PARK, ADHERING TO THESE RULES IS VITAL TO PROTECT THE FACILITY, THE CLUB, ITS MEMBERS AND SECURE THE USE OF THE LAND FOR YEARS TO COME.

THE PRACTICE FACILITY IS OPEN ON THURSDAY NIGHTS DURING THE SUMMER MONTHS FROM 5PM AND ALL-DAY SATURDAYS, SUNDAYS AND BANK HOLIDAYS (EXCEPT CHRISTMAS DAY) FROM 9:30AM TO DUSK.

1. THE PRACTICE FACILITY IS FOR **TRIALS BIKES ONLY**, THE USE OF ANY OTHER MOTORBIKE TYPE IS STRICTLY FORBIDDEN.
2. MOTORCYCLE HELMET, MOTORCYCLE BOOTS AND GLOVES MUST BE WORN AS A MINIMUM AT ALL TIMES WHEN RIDING AT THE FACILITY.
3. **UNDER 16S MUST BE SUPERVISED AT ALL TIMES BY THEIR PARENT/GUARDIAN REGISTERED ON THEIR MEMBERSHIP FORM.**
4. YOUR PRACTICE PASS MUST BE DISPLAYED ON YOUR BIKE AND BE FULLY VISIBLE TO OUR WARDENS AT ALL TIMES. OUR WARDENS WILL CARRY OUT REGULAR PASS CHECKS SO PLEASE BE ACCEPTING OF THIS.
5. **YOUR PRACTICE PASS BELONGS TO YOU, HENCE YOUR NAME AND PHOTO ID ON YOUR PASS, PASSES MUST NOT BE SOLD, LOANED, BORROWED OR TRANSFERRED BETWEEN PEOPLE.**
6. THE ACCESS GATE MUST REMAIN CLOSED AND LOCKED AT ALL TIMES, PLEASE CLOSE AND LOCK THE GATE EVERY TIME YOU ENTER OR LEAVE THE FACILITY. DO NOT ALLOW OTHER VEHICLES AND NON-MEMBERS TO ENTER.
7. **ALL CHILDREN NEED THEIR OWN PRACTICE PASS TO USE THE FACILITY; THEY ARE NOT A FREE ADD ON TO AN ADULT PASS.**
8. THE SPEED LIMIT FOR ALL VEHICLES ALONG THE ACCESS ROAD AND CARPARK IS 10MPH, PLEASE ADHERE TO THIS LIMIT AS WE HAVE HAD NEAR MISSES AND DAMAGE TO VEHICLES IN THE CARPARK.
9. **DO NOT PARK IN THE PICNIC AREA OR ON THE GRASS VERGES OUTSIDE OF THE ACCESS GATE.**
10. DO NOT RIDE OUTSIDE OF THE BOUNDARY FENCE, THE LAND SURROUNDING THE PRACTICE FACILITY IS PRIVATE PROPERTY.
11. **PLEASE DO NOT DISPOSE OF YOUR LITTER AT THE FACILITY, TAKE YOUR LITTER HOME FOR SAFE DISPOSAL.**
12. DO NOT CAUSE DELIBERATE DAMAGE TO THE FACILITY, ALSO THE REMOVAL OF ANY MATERIALS INCLUDING WOOD FROM THE FACILITY IS STRICTLY FORBIDDEN.

THE CLEVELAND WAY FOOTPATH RUNS THROUGH THE MIDDLE OF OUR PRACTICE FACILITY, THIS IS THE SINGLE BIGGEST RISK TO THE FUTURE USE OF THE LAND AS A PRACTICE FACILITY. THE PATH CAN ONLY BE CROSSED IN THE DESIGNATED AREAS WHICH HAVE SIGNAGE DISPLAYED FOR BOTH RIDERS AND USERS OF THE FOOTPATH, RIDERS ARE TO CROSS THE PATH WITH CAUTION AND GIVE WAY TO ALL PATH USERS AT ALL TIMES.

ANY COMPLAINTS TO THE NATIONAL PARKS AUTHORITY REGARDING THE FOOTPATH PUTS THE CLUB IN A DIFFICULT POSITION AND JEOPARDISES THE CLUB'S FUTURE USE OF THE LAND.
